3 GENERAL PRINCIPLES/RULES IN BRIEF

Reference: Art 20 (1) of Regulation (EU) No 305/2011; TB 13/77-CPD/2.1; TB 13/01/4.4; TB 16/14/10

- mandatory consultation periods: 1st consultation = 1 month (for EAD DP, 1st drEAD, 1st drETA); all subsequent consultations = 2 weeks; EC consultations – 3 weeks (15 working-days) = 21 calendar days
- 2. **communication-to-all** = to the concerned <u>and</u> the entire WG in copy
- 3. **circulation of comprehensive CHD throughout the whole process =** detailing TAB/EC consultant comments and RTAB answers
- 4. **commitment of all TABs** concerned = those in the designated product area, and where applicable, in related product areas

5 MODELS LETTERS (TO1) FOR ETA PROCESS AND EAD DPS

Due to the involvement of various parties in the ETA Process and the EAD development projects, the different steps need specific tasks with regard to completeness of the information and the transparency to the parties involved at a certain step.

EOTA has agreed on model letters which help aligning the communication internally in EOTA and hence the collaboration at EU level.

Note: The model letters are subject to regular modifications related to different new situations or new agreements with the concerned parties in order to keep the process smart.
